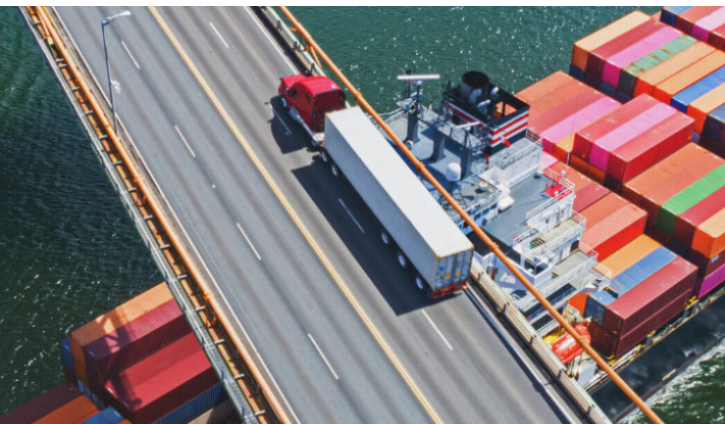


Introducing My T&T, a container tracking solution for the Seine Axis. The first web application by GIE easyport - available free of charge.




Formed in 2022 by HAROPA PORT and SOGET, a software publisher based in Le Havre, the mission of economic interest grouping GIE easyport is to ensure that goods flows along the Seine Axis are reliable, optimized and can be tracked.

As the first solution developed by easyport, **My T&T** allows users to determine the location of containers in the transport chain based on the container number, regardless of who has actual contractual responsibility for the containers concerned. This is key information for monitoring the passage of goods along the HAROPA PORT corridor.

Container movements registered in the Port Community System S)ONE are fed to the My T&T application, allowing the key information to be provided without loss of time.
